

Ashland-Greenwood Public Schools NSCAS, ACT, & AQUESTT Data Release 2024-2025 School Year (Spring)

Each year in the Spring, Nebraska Public Schools complete summative assessments currently called NSCAS (Nebraska Student Centered Assessment System). Grades third through eighth grade complete NSCAS Math and Reading. Fifth and eighth grade students also complete NSCAS Science. 11th grade students take the ACT for accountability purposes. Below are the proficiency levels for the different tests at the different grade levels for the 2024-2025 school year. Using this link, you are able to access five years of NSCAS data (bar graph format), which shows proficiency levels for 2020-21, 2021-22, 2022-23, 2023-24, and 2024-25. I have also included a chart that shows cohort data for the past five years.

AQuESTT Classifications

Nebraska statute requires the State Board of Education to create a system of accountability combining multiple indicators of school performance. The Accountability for a Quality Education System, Today and Tomorrow, or AQUESTT represents both an accountability system and a system of support built around six tenets. Each district receives an individual score. Many factors go into determining the final score. To receive a final designation of excellent, great, good or needs improvement, the metrics of academic achievement, academic progress, English Language Proficiency and Progress, Graduation Rate and School Quality or Student Success are used to create the final designation.
